Cost of illness studies are a type of economic study common in the medical literature, particularly in specialist clinical journals. The aim of a cost of illness study is to identify and measure all the costs of a particular disease, including the direct, indirect, and intangible dimensions.

Economic Note: Cost of illness studies

Hence, the friction cost (initial disruption costs plus training costs) is limited to the illness, injury, or premature death of the short term period defined as 'friction period.' It is presumed that the FCM will estimate a lower cost than the human capital method in the long run.

Cost-of-illness studies: concepts, scopes, and methods

Prevalence-based cost-of-illness analysis includes the total costs of an illness or disease within a specified time period, typically 1 year, regardless of when the disease first occurred.
